The 2019 Annual Report was reviewed by all present. Highlights included:

- a. Financial assistance from the Wisconsin Disaster Fund totaled \$11,370.68 for the August 28, 2018 tornado event and the March 14, 2019 flooding event.
- b. Garage/shop lights were upgraded to LED to save energy costs
- c. The 2000 Case IH Tractor was repaired for a cost of \$11,573
- d. The town received a \$600 Election Security subgrant
- e. Rustic Road was blacktopped at a cost of \$128,880
- f. Portions of Lomira Drive, West Line Road, Oaklane Road, Sunny Drive, and Butternut Drive were crack sealed for \$20,000
- g. Lomira Drive and Oaklane Road were seal coated for \$37,495
- h. Culverts were replaced on Amie Drive and Center Drive

A motion was made by Todd Ringle and seconded by Randy Dittberner to approve the 2019 Annual Report. Motion carried (5-0).

6. Set date and time for 2021 Annual Meeting

The 2021 Annual Meeting for the Town of Lomira will be held on Tuesday, April 21, 2021 at 6:30 pm.
