- Call to Order -- The monthly Board Meeting was brought to order at 6:30 p.m. by Chairperson Jeff Faber. He advised everyone to keep doors locked on vehicles, homes, and buildings to prevent unauthorized entry. He also warned against a phone scam involving phony delivery services that ask when residents are available to receive packages and thereby find out when homeowners are not present.
- b. Rob & Janel King presented information from the PASS group announcing that the WI Public Service Commission Environmental Assessment public comment period regarding the Springfield Solar Project was open until January 19, 2021. A PSC prehearing conference will be held Feb. 2, 2021 at 1:00 p.m. Directions were given out on how to file a public comment with the PSC and how to listen live to the prehearing conference. The information will be posted on the town's website.
