- 2. <u>Confirmation of Open Meetings notice</u> The clerk verified that the meeting was properly posted at the Town Hall & on the town's website: www.townoflomira.gov
- 3. Pledge of Allegiance -- The Pledge of Allegiance was recited.

Any changes to the Future Land Use map will be made through the county.

The Local Government Investment Pool (LGIP) was suggested as a way for the town to capitalize on higher interest rates.
